Hello Mr. Lucas,

You have my apologies, I thought I'd responded to this a while ago but it appears this slipped through the cracks.

Attached please find records responsive to your request for information.

In accordance with Vermont law, the identity of a controlling owner or principal of an applicant for a cannabis establishment license is confidential and exempt from public inspection under the Vermont Public Records Act. See [7 V.S.A. § 901\(h\)\(1\)\(A\)](#) and [7 V.S.A. § 881\(a\)\(1\)\(b\)\(i\)\(I\)](#). For that reason, the attached document does not include contact information for applicants who have not yet been issued a license.

In addition, information related to an applicant's or a cannabis establishment's security is confidential and exempt from public inspection under the Vermont Public Records Act. See [7 V.S.A. § 901\(h\)\(1\)\(A\)](#) and [7 V.S.A. § 901\(h\)\(1\)\(B\)](#). For that reason, the attached document does not include information that reveals an applicant's or cannabis establishment's precise location.

Nothing in this letter should be construed as a waiver of any privileges or protections over the records of the Cannabis Control Board. If you believe any records have been withheld in error, you may appeal this determination to the Chair of the Board pursuant to 1 V.S.A. § 318.
