Thank you for your patience as we worked on your records request.

You asked that the CCB produce:

All written communication between the state's Cannabis Control Board and any public officer, employee, or member of the local cannabis control commission for the Town of Charlotte between the dates of March 13, 2023 and March 22, 2023.

I operationalized your request by having members and staff collect all messages in that date range positive for "townofcharlotte.com" or the surnames you provided.

I can certify to you that I have found no direct communications in the specified date range between CCB members or staff and Charlotte officials, in either direction.

To ensure I've construed your request as you intended, I want to disclose that we possess records in which we and Charlotte officials are co-recipients of multi-recipient broadcasts from third parties.
