Hi Gabe,

Yes, that is correct. It would be the register as of today's meeting.

FYI, my interest in the most recent data is that I compare that to the most recent release of the cannabis excise tax data (released today for February) for tracking the average per-retailer sales. If the register shows that all 48 of the to-date applications were licensed and filed a tax report the sales rate would dramatically decline. The tax department gives me the actual number reporting which I use in the calculations. But the point is from what seemed to be a concern of many in today's meeting, consumer demand is not, and probably will not, keep pace with supply particularly if Tier 5 cultivators enter the market. At this time advertising will be critical to a retailer's success.
