Dear Mr. North:

Thank you for your request, and my apologies for the time it has taken to get you a reply.

We have located but one record concerning Oliver Duncan: A single-page university registration certificate. Though the content is minimal, I am due to withhold the document on the basis that it is a student record exempted from the Vermont Public Records Act by 1 V.S.A. 317(c)(11).

We have located more substantive content concerning Good Pot Co. A corporation identified as GPC LLC, doing business as Good Pot Co, has applied for a license to operate a tier-1 outdoor cultivation establishment in Orwell. The application is provisionally approved; however, no license has yet issued. Under State law, most of the information in an application for a cannabis establishment license is confidential and exempt from public inspection under the Vermont Public Records Act. See [7 V.S.A. § 901\(h\)\(1\)\(A\)](#) and [7 V.S.A. § 881\(a\)\(1\)\(B\)](#). This includes anything that might reveal the identity of controlling owners or principals, or that might compromise public safety, security, trade secrets, or information relating to operating plans. Licensee information related to employees is also confidential. For that reason, we cannot share most application materials.

If you believe any records have been withheld in error, you may appeal this determination to CCB Executive Director Brynn Hare, Esq., pursuant to 1 V.S.A. § 318. You may do that by emailing Ms. Hare directly ([brynn.hare@vermont.gov](mailto:brynn.hare@vermont.gov)) or by advising me that you would like her review.
