Dear Ms. Lemei,

After initially requesting pre-qualification applications involving Dustin Sherman and an Andover site, you expanded your request to reach all applications proposing sites in Andover.

We have located records indicating that Dustin Sherman has initiated a conventional (*i.e.*, not pre-qualification) application for a Tier 4 outdoor cultivation site in Andover, for Phantom Farms LLC. This is the only application located concerning an Andover site. The application has not been completed or determined at this time. Incident to the application under review, the CCB received the attached certificate of incorporation.

I am hopeful that these details satisfy your inquiry. For technical reasons, I am temporarily unable to access the electronic application materials themselves until Monday. Most application content is confidential by statute, but you are entitled to a statement of what documents we have in our custody, and if they must be withheld, the statutory basis for that decision.
