Thank you for your below records request, concerning materials submitted to the Cannabis Control Board relative to Ferngully Farm, LLC, license CLTV0244, located at 1824 VT RT 11 East in Chester, VT.

Under Vermont law, much of the information in an application for a cannabis establishment license is confidential and exempt from public inspection under the Vermont Public Records Act. See [7 V.S.A. § 901\(h\)\(1\)\(A\)](#) and [7 V.S.A. § 881\(a\)\(1\)\(B\)](#). This includes any content concerning security, trade secrets, or information relating to operating plans. Licensee information related to employees is also confidential.

Attached, please find a merged PDF document reflecting all responsive application attachments in our custody. Conspicuous black-box redactions are evident where I have found it necessary to obscure security information, trade secrets, and operating plans.

The law requires that I advise you that I am the person responsible for redacting the information described, that my title is as it appears beneath my signature, and that you may appeal my decision for review by CCB Executive Director Brynn Hare, Esq. (brynn.hare@vermont.gov) if you believe any element has been wrongly withheld.
