As for trimmers – that is not currently a specific license type. Trimmers would need to obtain a cannabis employee ID card in order to work for any kind of cannabis business, but we do not differentiate trimmers who hold an employee ID card from, for instance, budtenders (who are also required to hold an employee ID card).
