Thank you for your records request, which was forwarded to my office.

This year, Act 65, Sec. 21 directed the CCB to "work with the Vermont Academic Detailing Program, Registry patients and caregivers, licensed medical cannabis dispensaries, and medical professional stakeholders to review the Medical Cannabis Registry." *Id.*, Sec 21(a). The Board is to "convene the working group not less than four times to complete its work."

The Chair convened the first of four meetings on Tuesday, August 8th, at 10:00am. The working group has been open to anyone who wishes to participate, so it does not have a defined membership or list of appointees. The attached spreadsheet lists participants in the August 8 meeting and their affiliations. Some may be next-best-fits. For example, an attorney who represents medical professionals is listed as a medical professional.
