Thanks for your question. Lexis maintains Vermont's official Administrative Code here. It's useful for details that agency sites sometimes omit, including effective dates and Secretary of State rule log numbers. Details for the Board's four adopted rules are as follows:

- Rule 1, eff. March 29, 2022; Secretary of State Rule Log #22-008
- Rule 2, eff. March 29, 2022; Secretary of State Rule Log #22-009
- Rule 3, eff. April 19, 2022; Secretary of State Rule Log #22-014
- Rule 4, eff. April 19, 2022; Secretary of State Rule Log #22-015

The agency has proposed amendments to Rules 1, 2, and 4, and the notice and comment period is now closed. The proposed rule amendments will go before the Legislative Committee on Administrative Rules on October 5. There is a statutory 15-day holding period before rules may take effect. Assuming the Committee has no objections, anticipate an effective date between October 20 and November 1.

In 2022, the Board's pre-filing of Rule 5 met with unexpected controversy, and the text never was filed as a proposed rule with the Secretary of State. The agency is aware of the need to adopt a member-removal rule, and we intend to promulgate a new proposal when the current round of rulemaking is finished.
