Andrew,

Thanks for your patience . . . wanted to make sure I was aware of events very early in the Board's history.

The CCB has assessed the following administrative penalties:

1/23 - Gram Central LLC: \$1,000 suspended in contemplation of discharge if compliant with corrective action plan. Advertising violation.

1/23 - Green River Cannabis Co.: \$5,000, of which \$2,500 collected, \$2,500 suspended in contemplation of discharge if compliant with corrective action plan. Failure to test, log, register product.

2/23 - Tall Truck, LLC: \$40,000. Transporting cannabis out of state.

5/23 - Mend Botanical, LLC: \$20,000. Operating without required permits and selling unregistered cannabis.

6/23 - Holland Cannabis, LLC: \$37,000, of which \$27,300 collected, remainder expended on enhanced testing pursuant to settlement agreement. Adulteration by prohibited pesticide.

6/23 - Winooski Organics - \$1,000. On-site consumption.

7/23 - Vermont Terps, LLC: \$10,000. Unlicensed retail.

I have some feelers out to make sure I didn't miss anything in 2022, but I have high confidence in the accuracy of the list above, and I think it's not probable that the Board levied undiscovered penalties prior to the October 2022 opening of Vermont's adult-use market.

I should have a decisive answer about 2022 by Monday but wanted to get this off to you before the weekend. I'll follow up early next week if anything else is found.
