


## Adult Use Program – September 16, 2024 Active Licenses (564) by Type








# ADULT USE PROGRAM Total Active Licensees by Priority Status








### ADULT USE PROGRAM Total Active Licensees by Priority Status






### Adult Use Program – By County Licensees by Priority Status






#### ADULT USE PROGRAM Issued Cultivation Licenses (383) by Type and Tier








#### Manufacturer Licenses by Tier








# ADULT USE PROGRAM Average Days Pre-Qualification Submission to Pre-Qualification Approval Application Submission to License Issuance






#### ADULT USE PROGRAM Licensed Canopy Capacity Square Footage










#### ADULT USE PROGRAM – THREE MONTH VIEW Compliance Inspections












# MEDICAL PROGRAM Total Patient and Caregivers in Registry
