










Adult Use Program – February 25, 2025 Active Licenses (621) by Type






ADULT USE PROGRAM Total Active Licensees by Priority Status






ADULT USE PROGRAM Retail Locations by County








ADULT USE PROGRAM – COMPLIANCE Inspections (92) and Investigations (10)






Adult Use Program – Compliance Inspections







ADULT USE PROGRAM - FEBRUARY 2024 Compliance & Enforcement Actions






Adult Use Program Complaint Types (27)







Adult Use Program Notices of Violation - Types


